Note: * CEO of the SPV will be appointed with the approval of the MoUD. CEO will be appointed for a fixed term of 3 years & will be removed only with the prior approval of MoUD.

Since, for constitution of the SPV maximum 15 Directors have to be appointed, the proposal has been prepared for 10 Directors. Jalandhar should also propose some eminent citizen who could contribute in building up the Jalandhar City as a Smart City in years ahead.
