#### ORDER:

For the implementation of the Government of India Sponsored Smart Cities Mission in the State, Administrative Sanction has been issued vide the Government Order first read above.

- **2.** The Corporations of Greater Chennai, Coimbatore, Madurai, Vellore, Thanjavur, Salem, Tiruppur, Tirunelveli, Thoothukudi and Tiruchirapalli Corporations have been qualified as Smart Cities in the State of Tamil Nadu during the year 2015-16, 2016-17 and 2017-18.
- **3.** The Government of India has sanctioned one more city viz., Erode City Municipal Corporation as Smart City. As per Para 10 of the Smart Cities Mission Guidelines, to plan, implement, manage and operate the Smart City development projects, a City Level Special Purpose Vehicle (SPV) is required to be established for Erode City Municipal Corporation.
  - 4. The important aspects of Special Purpose Vehicle are as below:-
    - 1. The Special Purpose Vehicle will plan, appraise, approve, release of funds, implement, manage, operate, monitor and evaluate the Smart City development projects.

- 2. The Special Purpose Vehicle will be a limited company incorporated under the Companies Act, 2013 at the city-level, in which the State and the Urban Local Body will be the promoters having 50:50 equity share holding.
- 3. The initial paid up capital of the Special Purpose Vehicle will be Rs.200 crore. (Urban Local Body share Rs.100 crore and State share RS.100 crore). The Government of India will release Rs.194 crore for the first year.
- 4. The guidelines suggest that the key functions and responsibilities of the Special Purpose Vehicle contained therein will be included in the Articles of Association of the Special Purpose Vehicle.
- **5.** Based on the Mission Guidelines, Special Purpose Vehicles have been established for Chennai & Coimbatore vide G.O second read above and for Vellore, Madurai, Thanjavur and Salem Corporations vide G.O third read above and for Tiruppur, Tirunelveli, Thoothukudi and Tiruchirapalli Corporations vide Government Order fourth read above.
- **6.** On similar lines, a Special Purpose Vehicle has to be established for the recently approved Smart City viz., Erode Corporation.
- **7.** In the letter fifth read above, the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation and Mission Director, Smart Cities has sent proposal to Government for enabling Erode Corporation to form the Special Purpose Vehicle as mandated in the Guidelines of Smart Cities Mission.
- **8.** The Government, after careful examination of the proposal of the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation accord permission for the establishment of Special Purpose Vehicle for the Smart City of Erode Corporation as mandated in the Guidelines of Smart Cities Mission and accordingly issue orders on the following:
  - i. the composition of those SPV companies already formed in Tamilnadu ((i.e) Chennai, Coimbatore, Vellore, Madurai, Thanjavur, Salem, Tiruppur, Tirunelveli, Thoothukudi and Tiruchirapalli Special Purpose Vehicles) be adopted to the Special Purpose Vehicle for Erode Corporation.
  - ii. the Commissioner of the Erode Corporation shall apply for reservation of Name for the proposed company with the Registrar of Companies under the revised procedure recently announced by the Government of India for the name mentioned hereunder and for incorporation of the SPV subsequently as per new amended act and rules of the Companies Act 2013.

- vi. The Government have already approved Memorandum of Association and Articles of Association for Chennai and Coimbatore Smart City Special Purpose Vehicles. Further, permission was accorded to adopt the same for the Madurai, Salem, Vellore and Thanjavur, Tiruppur, Tirunelveli, Thoothukudi and Tiruchirapalli Smart Cities with modification in the Capital Clause of Memorandum of Association as per Table A of Companies Act 2013 and with exclusion of objects 25 to 38 of Clause III B of Memorandum of Association approved for Chennai and Coimbatore Smart City Special Purpose Vehicles vide Government letter No.1594/MA.2/2017-1, dated 31.01.2017. The Government permit the Erode Corporation to adopt the same to their Special Purpose Vehicle.
- vii. to register the company, initially, the authorised capital of the company be fixed as Rs.10,00,000/-, divided into 1,00,000 shares of Rs. 10/- each to be set out in Memorandum of Association.
- viii. the list of subscribers and their share holdings in the SPV are listed in the Annexure to this order. The address of subscribers mentioned in the annexure is the present address of the respective subscribers and the address may be changed as per address proof prescribed by the Companies Act-2013.
- the procedure for reserving name of the proposed company and rules for ix. Incorporation of Company under Companies Act, 2013 have been made by the Companies Amendment Act 2017. In revised procedure the reserving name will be done through web service viz., RUN (Reserve Unique Name) and incorporation will be done through e-form SPICe (Simplified Performa for incorporation of Companies Electronically) using Digital Signature (DSC) by all subscribers. Hence, the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation / the Commissioner of Municipal Administration, Chennai is authorised to do necessary arrangements for obtaining DSC from all the subscribers for the incorporation of the proposed SPV company as stated above and to issue letter for any modifications suggested and required by the Registrar of Companies in respect of the particulars mentioned in item no ii to viii above and in the Annexure to this order.
- **9.** The Commissioner of Municipal Administration is directed to pursue necessary action with reference to the orders issued in para 8 above in consultation with the Mission Director, Smart Cites Mission/ the Chairman and Managing Director, the Tamil Nadu Urban Finance and Infrastructure Development Corporation (TUFIDCO).
