- 1 Population Projection of the area at Macro Level after analysis of available demographic date from MCJ/PHED/ADA and census Report available approved data.
- 2 Study of population distribution in different Zones and population densities as per census 2011 or any latest ward wise densities available population distribution figures.
- 3 Population projections for different zones and projection of population densities in different colonies. If required.
- 4 Collection of data for existing water supply service level and projected water supply service levels for different zones, if required.
