Section I - Instructions to Bidders

A. General

1. Scope of Bid

1.1 With reference to the RFP notice, specified in the **Bid Data Sheet (BDS)**, the KSCCL, as specified **in the BDS**, issues this Bidding document for the provision of Works as specified in Section V, Work's Requirements. The name, identification, and number of lots (contracts) of this RFP are specified **in the BDS**.

1.2 Throughout this bidding document:

- a. the term "in writing" means communicated in written form (e.g. by mail, e-mail, fax, including, if specified **in the BDS**, distributed or received through electronic-procurement system used by the KSCCL) with proof of receipt;
- b. if the context so requires, "singular" means "plural" and vice versa; and
- c. "Day" means calendar day, unless otherwise specified as a "Business Day." A Business Day is any day that is a working day of GoAP. It excludes the GoAP's official public holidays.

2. Fraud and Corruption

2.1 KSCCL requires compliance with the Indian Penal Code 1860 and Prevention of Corruption Act 1988. KSCCL defines, for the purposes of this provision, the terms set forth below as follows

- a. "corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution; and
- b. "fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the Department, and includes collusive practice among bidders (prior to or after tender submission) designed to establish bid prices at artificial non-competitive levels and to deprive the benefits of free and open competition.

2.2 Any effort by a bidder to influence the Department in the Department's bid evaluation, bid comparison or contract award decisions may result in rejection of the bidder's tender.

2.3 The Department will reject a proposal for award if it determines that the bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question

2.4 In further pursuance of this policy, bidders shall permit and shall cause their agents (where declared or not), subcontractors, sub consultants, service providers, suppliers, and their personnel, to permit KSCCL to inspect all accounts,

	<p>records and other documents relating to any initial selection process, prequalification process, bid submission, proposal submission, and contract performance (in the case of award), and to have them audited by auditors appointed by KSCCL.</p>
<p>3. Eligible Bidders</p>	<p>3.1 A Bidder may be an Individual or a firm that is a private entity, a state-owned enterprise or institution or any combination of such entities in the form of a joint venture (JV) under an existing agreement or with a new JV agreement entered solely for the purpose of the said bid. In the case of a joint venture, all members shall be jointly and severally liable for the execution of the entire Contract in accordance with the Contract terms. The JV shall nominate a Representative who shall have the authority to conduct all business for and on behalf of any and all the members of the JV during the Bidding process and, in the event the JV is awarded the Contract, during contract execution. The Maximum number of JV members eligible is specified in the BDS.</p> <p>3.2 A Bidder shall not have a conflict of interest. Any Bidder found to have a conflict of interest shall be disqualified. A Bidder may be considered to have a conflict of interest for the purpose of this Bidding process, if the Bidder:</p> <ul style="list-style-type: none"> (a) directly or indirectly controls, is controlled by or is under common control with another Bidder; or (b) has the same legal representative as another Bidder; or (c) has a relationship with another Bidder, directly or through common third parties, that puts it in a position to influence the Bid of another Bidder, or influence the decisions of the Employer regarding this Bidding process; or (d) has a close business or family relationship with a professional staff of the KSCCL who: (i) are directly or indirectly involved in the preparation of the Bidding document or specifications of the Contract, and/or the Bid evaluation process of such Contract; or (ii) would be involved in the implementation or supervision of such Contract. <p>3.3 A firm that is a Bidder (either individually or as a JV member) shall not participate in more than one Bid, except for permitted alternative Bids. This includes participation as a subcontractor in other Bids. Such participation shall result in the disqualification of all Bids in which the firm is involved.</p> <p>3.4 A Bidder may have the nationality of any country, subject to the restrictions pursuant to ITB 3.5. A Bidder shall be deemed to have the nationality of a country if the Bidder is constituted, incorporated or registered in and operates in conformity with</p>

	<p>the provisions of the laws of that country, as evidenced by its articles of incorporation (or equivalent documents of constitution or association) and its registration documents, as the case may be.</p> <p>3.5 The bidder shall not have been blacklisted by any of the Central government/ State government/ Semi- government/ PSU's of central/ state governments.</p> <p>3.6 Firms of all countries are eligible to apply - Deleted.</p> <p>3.7 A Bidder shall provide such documentary evidence of eligibility satisfactory to the KSCCL, as the KSCCL shall reasonably request.</p>

<p>5. Clarification of Bidding</p>	<p>5.1 A Bidder requiring any clarification of the Bidding document shall contact the KSCCL in writing at the address specified in the</p>

<p>Document, Site Visit, Pre-Bid Meeting</p>	<p>BD SoR raise it in writing during the pre-Bid in writing. The KSCCL will respond in writing to any request for clarification, provided that such request is received prior to the deadline specified in Key Dates. The KSCCL shall upload the responses online in the AP e-procurement portal and its website and through mails to the intended bidder who have attended the pre-bid meeting or who have raised queries. It is the bidder's responsibility to check the portal regularly for any updates/postings. KSCCL will not hold any responsibility of posting the same to individual bidders.</p> <p>5.2 The Bidder is advised to visit and examine the Site of Works and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the Bid and entering into a contract for construction of the Works. The costs of visiting the Site shall be at the Bidder's own expense.</p> <p>5.3 The Bidder and any of its personnel or agents will be granted permission by the KSCCL to enter upon its premises and lands for the purpose of such visit, but only upon the express condition that the Bidder, its personnel, and agents will release and indemnify the KSCCL and its personnel and agents from and against all liability in respect thereof, and will be responsible for death or personal injury, loss of or damage to property, and any other loss, damage, costs, and expenses incurred as a result of the inspection</p> <p>5.4 The Bidder's designated representative is invited to attend a pre-Bid meeting and/or a Site of Works visit. The purpose of the meeting will be to clarify issues and to answer questions on any matter that may be raised at that stage.</p> <p>5.5 The Bidder is requested to submit any questions in writing, to reach the KSCCL not later than the time specified in 'Key Dates'.</p> <p>5.6 Minutes of the pre-Bid meeting, if applicable, including the text of the questions asked by Bidders, without identifying the source, and the responses given, together with any responses prepared after the meeting, shall also publish the clarifications as given in ITB 5.1 and Minutes of the pre-Bid meeting at the web page identified in the BDS. Any modification to the Bidding document that may become necessary as a result of the pre-Bid meeting shall be made by the KSCCL exclusively through the issue of an Addendum pursuant to ITB 6 and not through the minutes of the pre-Bid meeting. Cost of Bidding</p>	<p>7.1 The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the KSCCL shall not be responsible or liable for those costs, regardless of the conduct or outcome of the Bidding process.</p> <p>7.2 Transaction Fee: It is mandatory for all the participating bidders to pay electronically the Transaction fee to M/s Vupadi Techno Service (P) Ltd through "Payment Gateway Service on E-Procurement platform". The Electronic Payment Gateway accepts all Master and Visa card issued by any bank and Direct Debit facility / Net Banking of ICICI Bank, HDFC to facilitate the transaction. This is in compliance as per G.O Ms No 13 IT & C Dept., dated 5-7-2006. A Service Tax of 15 % + Bank Charges for Credit Card Transaction of 1.85% on the transaction Amount payable to M/s Vupadi Techno Service (P) Ltd shall be applicable which is non-refundable. The Transaction fee payable is specified in the BDS.</p> <p>7.3 Bid Processing Fee: A bidding processing fee is payable by the bidder in the form of a Demand Draft drawn in the name of Kakinada Smart City Corporation Limited payable at Kakinada. Scanned Copy of the demand draft shall be uploaded during the bid submission and shall be physically submitted along with the bid. The Bid Processing fee payable is specified in the BDS.</p>

10. Letter of Bid and Schedules	<p>10.1 The Letter of Bid and Schedules, including the Bill of Quantities, shall be prepared using the relevant forms furnished in Section IV, Bidding Forms. The forms must be completed without any alterations to the text, and no substitutes shall be accepted except as provided under ITB 18.3. All blank spaces shall be filled in with the information requested.</p>
11. Alternative Bids	<p>11.1 No alternative Bids shall be considered. Bidders submitting unsolicited alternative proposals will be summarily rejected.</p>
12. Bid Prices and Discounts, Taxes, Duties etc.	<p>12.1 The prices quoted by the Bidder in the Letter of Bid and in the Bill of Quantities shall conform to the requirements specified below.</p> <p>12.2 The Bidder shall fill in rates and prices for all items of the Works described in the Bill of Quantities. Items against which no rate or price is entered by the Bidder shall be deemed covered by the rates for other items in the Bill of Quantities and will not be paid for separately by the Employer.</p> <p>12.3 The price to be quoted in the Letter of Bid, in accordance with ITB 10.1, shall be the total price of the Bid.</p> <p>12.4 VOID</p> <p>12.5 Unless otherwise specified in the BDS and the Conditions of Contract, the rates and prices quoted by the Bidder are fixed.</p> <p>12.6 If so specified in ITB 1.1, Bids are being invited for individual lots (contracts) or for any combination of lots (packages). Bidders wishing to offer discounts for the award of more than one Contract shall specify in their Bid the price reductions applicable to each package, or alternatively, to individual Contracts within the package. Sealing and Marking of Bids</p>	<p>19.1 Unless specified in BDS in detail about submission process of the bid the following is to be followed.</p> <p>19.2 The Bids needs to be submitted on the e-tendering portal i.e., https://tender.apecurement.gov.in.</p> <p>19.3 (A) Physical bid submission should be by hand shall enclose the original of the Technical Bid and copy of the Technical Bid in separate sealed envelopes, duly marking the envelopes as "ORIGINAL - TECHNICAL BID", and "COPY NO... - TECHNICAL BID". These envelopes, the first containing the originals and the others containing copies, shall then be enclosed in one single envelope per set. If permitted in accordance with ITB 11, alternative bids shall be similarly sealed, marked and included in the sets. A. Work Requirements

1.0 BACKGROUND

With the India Smart Cities Challenge, the Government of India took the first step towards realizing its vision of building 100 smart cities in the country. As part of the India Smart Cities Challenge, Kakinada is one of the cities that were selected amongst top 20, in a nationwide competition between 100 cities (ranked 14th).

Kakinada is now working on an implementation plan to convert the Smart City Proposal (SCP) ideas into reality, beginning with retrofitting a designated area within the city known as the Area Based Development (ABD) that will catalyze future scalability to entire city.

Kakinada the district headquarters and a seaport city on the Bay of Bengal is located in the East Godavari District of Andhra Pradesh State. It is located 65km from Rajahmundry. It is the headquarters and largest city of East Godavari district. Kakinada is part of a Special Economic zone and proposed petroleum, Chemical and Petrochemical Investment Region (PCPIR). The Kakinada Municipal Corporation (KMC) population 3,25,985, and administrative boundary spreads over the 30.15 sq.km area and divided into 50 wards, and total roads of 474 km.

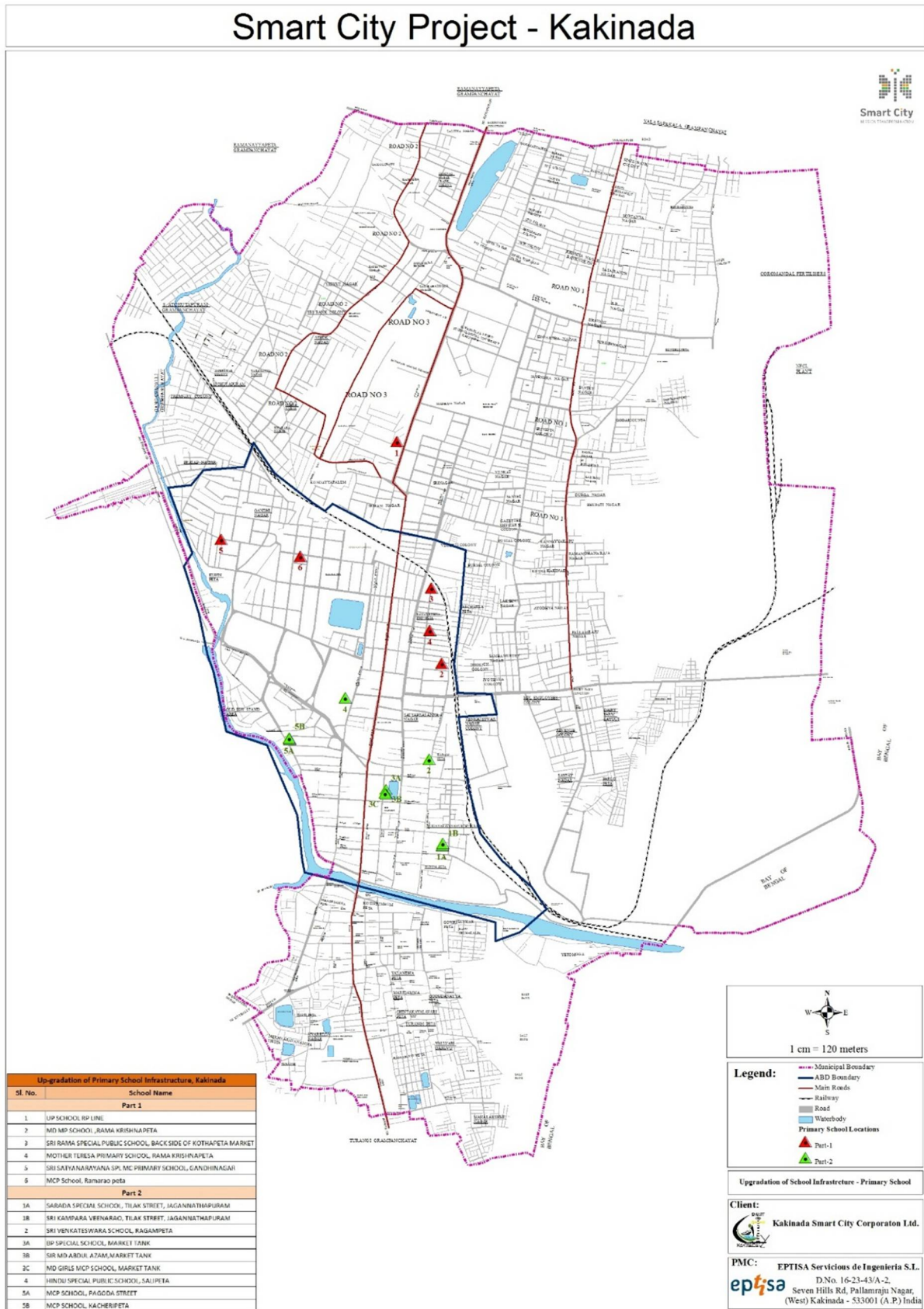

- Creating an identity for all KMC schools
- Creating clean and green education campuses,
- Providing active outdoor spaces for sports and extra-curricular activities,
- Providing universal accessible design in all schools,
- Nurturing nature based teaching,
- Equip schools with technology based learning resources
- Equip schools to have interactive learning sessions with other schools
- Equip schools to have video conferencing where a teacher in one location is able to teach/interact with students from other schools in different locations

3.0 PROJECT OBJECTIVE AND EXPECTED OUTCOMES

The Employer has developed a CONCEPT DESIGN for Modernizing KMC schools as Smart Campus. This entails comprehensive upgrading of the school facility which includes (but is not limited to) - equipping schools with technology based learning resources, **external development works for hardscape, softscape, site furniture, lighting, signage in the open areas & park, and refurbishment of existing toilet blocks. In addition, façade improvement works (internal and external wall finishes) is to be carried out.**

Modernizing KMC schools as Smart Campus include **Two Broad** Objectives are:

A. Identity

B. Health & Wellness

The Implementing Agency should ensure that the project implementation achieves all objectives and expected outcomes.

A. IDENTITY: Rebranding KMC schools. Create a uniform identity of all KMC schools.

EXPECTED OUTCOME

- Uniform identity of all KMC schools in terms of façade improvements and signages. This includes standardized KMC schools signages, external wall surfaces and internal building improvements (wall surfaces of classrooms, common areas etc) as per concept design.
- Create Playful learning environment through use of colourful Jali (screen) details. Create safe learning environment for children by providing colourful Jali (screen) at specified locations to avoid unwanted accidents.

B. HEALTH AND WELL BEING: Access to play areas, increases frequency of exercise and reduces non-communicable diseases like obesity. Physical Activity makes people healthier. Provide clean and green education campus to enhance learning and teaching environments

EXPECTED OUTCOME

- More outdoor activity areas for students to provide them opportunities for greater physical activity. Contact with nature improves physical and psychological health; those in a greener

environment people report fewer health complaints, more often rate themselves as being in good health, and have better mental health.

- Optimum use of under-utilized land within school premises by creation of functional spaces
- Improved health and sanitation condition through RO facility for clean drinking water (non-bottled) and refurbished toilets
- Reduced paved areas in schools through addition of pervious surfaces and playgrounds/sport courts, thus reduction in urban heat island effect
- Preservation of all existing trees and addition of new trees and landscaping elements
- Dedicated spaces for nature based learning and rain water harvesting
- Universal accessible design through creation of ramps for access to schools and classrooms
- Enhanced learning environment through clean and green education campus
- Safe and secure school premise through cctv and motion sensor external lighting

4.0 SCOPE OF WORK

Scope of work includes **Identity + Health & Wellness** and the details are in alignment with the project objectives.

4.1 Scope of work to achieve the objectives

Applying the design principles, Objective and expected outcomes illustrated in the RFP as well as attached drawings/ requisite documents provided by the Employer, the Implementing Agency must develop on the concept provided, to create a good for construction (GFC) drawings package, on approval from the Employer, shall be followed by on-site implementation. During this process, the Implementing Agency shall review the concepts design and planning for betterments or improvements which may be incorporated to better achieve the Employer's goals and objectives. These betterments, if any, shall be submitted by the Implementing Agency to the Employer for review and for the approval before the closure of the Good for construction drawings stage.

Key tasks/deliverables by the Implementing Agency will include:

- The Implementing Agency should submit a complete timeline for scope of work to be carried out
- The Employer will supervise and monitor the progress and Implementing Agency shall provide necessary coordination.
- Preparation and Submission of Complete Bill of Materials (BoM) along with detailed technical specifications, manufacturer's name and delivery schedule at the sites. Shall also provide the codification for all the items delivered.
- Preparation and submission of the details of the man power deployment for the project.
- Dispatch of materials as per the implementation timelines.
- Preparation and submission of periodical progress report for all the stages
- Carrying of Field/Site Survey/Geo-Technical Survey: The Implementing Agency shall conduct site survey of the schools where the design is to be implemented; and prepare the survey report highlighting the site feasibility, GFC drawings, any site-specific requirements / dependencies for successful implementation.

- Implementing agency should ensure that there is least disturbance to the schools and also ensure safety of the children while working. Any negligence in the safety of students and staff will be treated seriously and may even lead to cancellation and prosecution of agency.

The Implementing Agency shall prepare GFC for the following works in accordance with the concept design developed by Employer.

a) Façade Works

- Proposed Façade and Internal Building Improvements, Façade Signage fixing details, location for individual frontages and allied services.
- All detail construction drawings suitable for construction works to be undertaken by competent Implementing Agency
- All necessary coordinated services drawings (including but not limited to location of light fixtures etc.)
- Shop drawings for all proprietary items/vendor items

b) Landscape Works

- General Arrangement Plans (Surface Finishes Layouts) including Materials, Site Furniture, Play equipment etc.
- Levels and Grading Layouts; Material/Lighting/Furniture Schedules; Hardscape Details (including concrete ramps and benches); Lighting & CCTV layout & details; planting schedule; planting and soil details
- Design and preparation of GFC for items listed in Employer's BoQ
- Hard Landscape Specification including all details in Employer's Bill of Quantities (BoQ) and Technical Specs
- Softscape Specifications including all details in Employer's BoQ and Technical Specs
- Final Setting-Out Plan for hardscape, softscape, ; furniture, signage and lighting
- All detail construction drawings suitable for construction works to be undertaken by competent Implementing Agency
- All necessary coordinated services drawings (including but not limited to location of light fixtures, water tanks, existing site services and any new added services etc.)
- Shop drawings for all proprietary items/vendor items

The Implementing Agency must be aware of general and specific site conditions, topography and any existing landscape prior to commencement of any landscape works on site.

4.2 Construction Scope: The on-site execution scope of work comprises of full, final and entire installation and completion of landscape works to a 'best practise standard' for such works, (inclusive of hardscape, softscape, site furniture, exterior signage and lighting) and associated landscape services (levelling, drainage etc.) based on the design developed by the Employer and Implementing Agency's good for construction drawings and handing over of the same in full accordance with the Employer's requirements. Key tasks include:

- The Implementing Agency should submit a complete implementation timeline
- The Employer and/or Employer's representative will supervise and monitor the progress of the implementation of the work and solution.

- Technical Specifications for Various Works to be followed in the project duration including Defect Liability Period, by the Selected Bidder.
- Mixed Design calculations with Material properties of Fine aggregate and coarse aggregate and cement etc.

Material/Product samples:

- All materials/samples to be submitted to the Employer for comments and approval prior to commencement of works;
- Type and number of samples as specified in relevant sections of this document.
- Sample panels:
 - Mock-ups - All sample panel/mock-up to be presented to the Employer for comments and approval prior to commencement of works through transmittal;
 - Type and number of sample panels as specified in relevant sections of this document.
- As-built drawings:
 - The Implementing Agency shall prepare As-Built drawings and certify on these drawings that the drawings reflect the actual works installed. Any deviations to be marked in block.
 - Three sets of these drawings (A1 hardcopy, printed to scale and softcopy – AutoCAD and PDF on a CD) shall be submitted to the Employer post approval and record (Black & White and Color/Size of drawings) as desired by the employer for specific drawings.
 - The Implementing Agency shall ensure that this submission of As-Built drawings will not delay subsequent inspections and tests by the relevant authorities; otherwise he shall be fully responsible for any consequence due to his delay.

4.3 General scope

Conceptual plans are given in the RFP of the bid. Execution of the works shall be based on working drawings given by the Employer. However, the tentative quantities for each school indicated in the Annexure for information only.

Contractor shall do all necessary co-ordination activities with KSCCL & PMC for seamless implementation of the said works.

- a) The scope of work covers the detail design, supply and installation of all landscape works (hardscape, softscape), façade works and allied civil and (Electrical, AC and IT) services work. The Implementing Agency shall furnish all labour, material, tools and equipment necessary to complete the works as indicated on the drawings. Any item not specifically shown in the drawings or specified but normally required to conform to such intent, should be considered part of the work unless raised by the Implementing Agency prior to commencement of works. Implementing Agency shall include and price for such item in the BOQ accordingly as per MORTH specifications;
- b) Any item not covered under the BOQ shall be paid to the contractor based on the Latest AP SOR available on the date bidding.
- c) Any item not covered in SOR, those items will be paid as per local prevailing rates.
- d) All works indicated in the Drawings by notes are to be provided for, whether or not mentioned in this specification. Any item not specified nor specifically shown in the drawings, but are normally required to conform to such intent, are considered part of the work and deemed to be included in this contract and their execution shall be covered by the contract price, in the same manner as if they have been expressly shown on the drawings and described in the specifications.

- e) The works shall be completed within the scheduled time and shall be certified by the Employer upon Practical Completion;
- f) The landscape planting shall be provided in the areas shown in the Drawings with plants in a healthy and vigorous growing condition.
- g) The Implementing Agency shall submit for approval, his proposed Work Programme based on the criteria of the overall programme showing the intended sequences, stages and order of proceeding with the works together with the period of time he has estimated for each and every stage of the progress upon receipt of notification of award of project.;
- h) The Implementing Agency shall provide/arrange sufficient portable toilets during the construction time and/or during the reconstruction of existing toilets to avoid any inconvenience to the school staff and students during school timings of type A and/or Type B as given below:
 - (A) Portable Toilets Without Wheel:
 - (i) Minimum Size : 1m x 1m x 2.5 m / (3'X3'X8')
 - (ii) Lockable door facility with roof.
 - (iii) Water supply connection with or without Push Button Type

<p>17.2 CONTRACTOR'S CARE OF THE WORKS</p>	<p>The Contractor shall take full responsibility for the care of the Works and Goods from the Commencement Date until the Taking-Over Certificate is issued (or is deemed to be issued under Sub-Clause 10.1 [Taking Over of the Works and Sections]) for the Works, when responsibility for the care of the Works shall pass to</p>

<p>18.3 INSURANCE FOR CONTRACTOR’S PERSONNEL</p>	<p>The Contractor shall effect and maintain Workmen’s Compensation Insurance/ equivalent insurance against liability for claims, damages, losses and expenses (including legal fees and expenses) arising from injury,</p>

	<p>sickness, disease or death of any person employed by the Contractor or any other of the Contractor's Personnel.</p> <p>The insurance shall cover the Employer and the Engineer against liability for claims, damages, losses and expenses (including legal fees and expenses) arising from injury, sickness, disease or death of any person employed by the Contractor or any other of the Contractor's Personnel, except that this insurance may exclude losses and claims to the extent that they arise from any act or neglect of the Employer or of the Employer's Personnel.</p> <p>The insurance shall be maintained in full force and effect during the whole time that these personnel are assisting in the execution of the Works. For a Subcontractor's employees, the insurance may be affected by the Subcontractor, but the Contractor shall be responsible for compliance with this Clause.</p>

<p>19.2 NOTICE OF FORCE MAJEURE</p>	<p>If a Party is or will be prevented from performing its substantial obligations under the Contract by Force Majeure, then it shall give notice to the other Party of the event or circumstances constituting the Force Majeure and shall specify the obligations, the performance of which is or will be prevented. The notice shall be given within 14 days after the Party became aware, or should have become aware, of the relevant event or circumstance constituting Force Majeure.</p> <p>The Party shall, having given notice, be excused performance of its obligations for so long as such Force Majeure prevents it from performing them.</p> <p>Notwithstanding any other provision of this Clause, Force Majeure shall not apply to obligations of either Party to make payments to the other Party under the Contract.</p>

<p>19.4 CONSEQUENCES OF FORCE MAJEURE</p>	<p>If the Contractor is prevented from performing his substantial obligations under the Contract by Force Majeure of which notice has been given under Sub-Clause 19.2 [Notice of Force Majeure], and suffers delay and/or incurs Cost by reason of such Force Majeure, the Contractor shall be entitled subject to Sub-Clause 20.1 [Contractor's Claims] to:</p> <ul style="list-style-type: none"> (a) an extension of time for any such delay, if completion is or will be delayed, under Sub-Clause 8.4 [Extension of Time for Completion], and (b) if the event or circumstance is of the kind described in sub-paragraphs (i) to (iv) of Sub-Clause 19.1 [Definition of Force Majeure] and, in sub-paragraphs (ii) to (iv), occurs in the Country, payment of any such Cost, including the costs of rectifying or replacing the Works and/or Goods damaged or destroyed by Force Majeure, to the extent they are not indemnified through the insurance policy referred to in Sub-Clause 18.1 [Insurance for Works and Contractor's Equipment]. <p>After receiving this notice, the Engineer shall proceed in accordance with Sub-Clause 3.5 [Determinations] to agree or determine these matters.</p>
<p>19.5 FORCE MAJEURE AFFECTING SUBCONTRACTOR</p>	<p>If any Subcontractor is entitled under any contract or agreement relating to the Works to relief from force majeure on terms additional to or broader than those specified in this Clause, such additional or broader force majeure events or circumstances shall not excuse the Contractor's non-performance or entitle him to relief under this Clause.</p>
<p>19.6 OPTIONAL TERMINATION, PAYMENT AND RELEASE</p>	<p>If the execution of substantially all the Works in progress is prevented for a continuous period of 84 days by reason of Force Majeure of which notice has been given under Sub-Clause 19.2 [Notice of Force Majeure], or for multiple periods which total more than 140 days due to the same notified Force Majeure, then either Party may give to the other Party a notice of termination of the Contract. In this event, the termination shall take effect 7 days after the notice is given, and the Contractor shall proceed in accordance</p>

	<p>with Sub-Clause 16.3 [Cessation of Work and Removal of Contractor's Equipment].</p> <p>Upon such termination, the Engineer shall determine the value of the work done and issue a Payment Certificate which shall include:</p> <ul style="list-style-type: none"> (a) the amounts payable for any work carried out for which a price is stated in the Contract; (b) the Cost of Plant and Materials ordered for the Works which have been delivered to the Contractor, or of which the Contractor is liable to accept delivery: this Plant and Materials shall become the property of (and be at the risk of) the Employer when paid for by the Employer, and the Contractor shall place the same at the Employer's disposal; (c) other Cost or liabilities which in the circumstances were reasonably and necessarily incurred by the Contractor in the expectation of completing the Works.
