Details of Expression of Interest

2. Eligibility Criteria for empanelment

The agency should have past experience of implementing connectivity, laying fiber, network implementation, offering leased line, bandwidth, establishing wireless radio based connectivity, hybrid connectivity etc at city level. The agency must possess the requisite experience, organizational strength and capabilities in providing the services necessary to meet the standard requirements of such projects. Keeping in view the complexity & volume of the work involved, the following shall be the criteria for EOI Responder:





- 1. The Respondent should be a company registered and operating under the Indian Companies Act, 1956 since April 1, 2014 or earlier. **Copy of certificate of incorporation / registration to be submitted.**
- 2. The Respondent should be an established Companies/ OEMs / System Integrators/authorized representative of OEM being in this business of IT and related solutions and services opportunities for a period exceeding Three years and having required connectivity/network licenses as relevant to such requirements. (Certificate from MD stating the above should be submitted)
- The Responder must have on its roll, technically qualified professionals in the area of Project Management / Electronics Security Systems / System Integration / Networking / Wireless solutions and other similar domain pertaining to their offerings. (Details to be provided in the attached format no 4 of Annexure-B
- 4. The Responder shall not be under a declaration of ineligibility for corrupt or fraudulent practices or blacklisted with any of the Government agencies. (Certificate from the MD of the respondent)
- 5. The applicant should have positive net worth (Certificate from their statutory Auditors)
- 6. Applicant is required to submit an undertaking by the company secretary that they have no case pending / registered with B.I.F.R and that no recovery proceedings have been initiated by any bank or other regulatory body against their company.
- 7. Should have GST and PAN (Copies needs to be provided)

3. Requirement for empanelment:

- 1. Relevant and quality of experience of delivery, implementation and maintaining network connectivity.
- 2. The Respondent must provide list of places where such connectivity implementation have been carried out and/or are being maintained by them with copies of Work order or purchase order copies etc.
- 3. The Respondent must demonstrate through documentation, their technical expertise, experience, facilities, and capabilities necessary to perform the work in a satisfactory manner.

Domain knowledge and experience of Citywide network offerings (implementing connectivity, laying fiber, network implementation, offering leased line, bandwidth, establishing wireless radio based connectivity, hybrid connectivity etc) with government / civic body would be preferred.

4. Document submission for empanelment

- The Responder have to provide turnover details of the last three preceding years (2014-2015, 2015-2016, 2016-2017). The Responder must attach audited accounts as supporting documents. Un-audited accounts will not be considered.
- 2. The Responder should submit the details of the projects carried out by them during the last three years.
- 3. The Responder should be financially sound. The Responder shall submit net worth of the company as per Audited Annual report for the last three financial years preceding the last date of submission of the proposals.





4. The Responder should furnish GST tax registration details and Permanent Account Number (PAN) issued by income Tax department.

5. Empanelment Process

The following process will be followed while empaneling the agency:

- 1. (n)Code shall review the applicant details provided in the formats. Incomplete information may render the applicant disqualified.
- 2. (n)Code shall validate the experience claims and satisfy itself. The committee may call for suitable clarifications including documentary evidences, clarification from clients and presentation at its discretion, as it may deem fit, to satisfy itself about the ability of the respondent.
- 3. The decision of (n) Code management shall be final and binding to all for the assessment, completeness, relevance and quality of experience.

6. General Conditions

- a. (n)Code solutions, A Div. of GNFC Ltd. reserve the right to empanel one or multiple vendors under the same category. Decision of (n)Code in this regard will be final and binding.
- b. (n)Code reserves to accept / reject any or all the Responses without giving the reasons thereof.
- c. The purpose of this EoI is to empanel the interested agencies for connectivity requirement for smart city and similar opportunities. (n)Code may engage with empaneled agency subject to their fitment for responding for the specific opportunities. It reserves the right to engage / not to engage the empaneled agency for the project and is free to go with the agency not empaneled through this EoI.
- d. Eol document must be signed by the authorized person of the company. The Power of Attorney in the name of the Authorized person should be submitted along with the bid. All pages should be sealed and signed by the authorized signatories.
- e. Applicant must submit a declaration that applicant has never defaulted or blacklisted regarding poor performance/delivery or declared ineligible for corrupt and fraudulent practices in any department of Government of India or State Govt. or any agency in India .
- f. The incomplete application for empanelment will be rejected.
- g. All the costs incurred for preparing the responses to this EoI shall be borne by the applicant
- h. (n)Code reserves the right to accept or reject in part or full any or all the EOIs without assigning any reasons therefore and without incurring any liability to the respondent.
- i. Enclose the valid certifications like ISO 9001:2008, ISO 20000:2011, ISO 27001: 2005, CCMI, ISO 14001, OHSAS 18001 of your organization, if applicable.
- j. Enclose the valid certifications, licenses related to network, connectivity, leased line, bandwidth, wireless etc
- k. Authorized partners of OEM / SP of the products can also empanel but need to attach authorization certificate for selling, support, update and services from the OEM.
- I. The key commercial terms of downstream engagement shall be as per the terms of the RFP and for the contract period viz. back to back delivery, warranty support, SLAs, penalties, if any and payments.

7. Future engagement method

- 1. (n)Code shall invite technical solutions and compliances from the empaneled vendors for the services, solutions they are empaneled as and when opportunity arises.
- 2. Based on response to #1 above, (n)Code shall engage with the shortlisted Agencies for the respective services, solutions for designing the network architecture and preparation of bill of material and finalizing cost for bidding.
- 3. The agency will be required to carry out the feasibility study for the connectivity requirement and have to submit system architecture document for required connectivity based on the feasibility survey to (n)Code.
- 4. (n)Code shall, based on the scope, fitness of design and compliances and cost, signup the teaming agreement for bidding.
- 5. Subject to winning the bid, (n)Code may engage with agency for execution of the project as per the terms of the teaming agreement
