The indicative Scope of Work is mentioned under Section 7 of the EOI.
- ii. The last date of submission of proposal is mentioned under Schedule of Bid Process
- 3.2 About Agartala

Location of the City:

Agartala, the capital of Tripura, is situated along 23° 45′- 23° 55′ N latitude and 91°15′- 91°20′ E longitude, in the flood plains of the Haora River. Historically, the city has been an important border-trading town with trading linkages with Bangladesh. The National Highway (NH)-44 connects Agartala with Silchar, Guwahati and other towns of Assam. Agartala is connected by air links to rest of the country.

Climate:

The climate of Agartala is of tropical monsoon type. The average annual rainfall is around 220 centimeters (cm). The average no of rainy days is 100 days. The temperature varies from 4.2°c to 37.6° on the average. The winter period is from November to February, summer is from March to May and monsoon is from June to September. It has a moderate temperature and highly humid atmosphere. Winds, which are of moderate velocity, are from the south-to-south – east direction for most of the time. Average velocity of wind varies from 4 km to 9 km per hour.

Topography:

The city of Agartala has an altitude of 12.8 metres. The erstwhile AMC area, the central portion of the city is located in an area lower than the surroundings. The central portion of the city is shaped like a saucer. The central portion is bounded by the rivers Haora in the south and Katakhal in the north. Due to its saucer shape, the city is vulnerable to recurrent flooding during monsoons. The city is located in seismic zone V.

3.3 About Agartala Smart City Limited

In line to the guidelines issued by Ministry of Urban Development (MoUD)/Government of India (GoI) Government of Tripura has created a Special Purpose Vehicle (SPV) Agartala Smart City Ltd (ASCL) for implementing the Smart City mission at the city level.

ASCL will plan, appraise, approve, release funds, implement, manage, operate, monitor and evaluate the Smart City development projects. ASCL is headed by full time CEO and have nominees of Central Government, State Government and AMC on its Board.

The key functions and responsibilities of ASCL are to;

- i. Approve and sanction the projects including their technical appraisal
- ii. Take measures to comply with the requirements of MoUD with respect to the implementation of the Smart Cities programme
- iii. Undertake review of activities of the Mission including budget, implementation of projects etc. and co-ordination with other missions / schemes and activities of various ministries

3.4 Project Background

Agartala Smart City Limited (ASCL) proposes to use Wi-Fi facility for better governance, and to improve the operational efficiency and to easily interact with citizens.

ASCL is also exploring the viability to provide Wi-Fi Service at selected locations (Refer Enclosure-I of the RFP), on a Public Private Partnership (PPP) Model. The list of locations may increase or decrease during RFP stage.

ASCL is interested in understanding, if any innovative ways there might be to provide Wi-Fi Services to citizens at either no cost to ASCL or if possible as a potential source of revenue, which could be shared between both the parties.

3.5 Objective

Agartala Smart City Limited (ASCL) is seeking 'Expression of Interest' (EOI) for setting up of secured Wi-Fi network on PPP mode at various important locations such as Hospitals, Educational Institutes, Airport, Railway Stations etc. from leading Vendors/Service Providers/Original Equipment Manufacturers (OEM). Interested eligible firms are requested to submit their detailed proposal in sealed envelope. The proposal shall be written in English. The potential benefit from this includes easier access to Internet Services thereby increasing the ease of communications in the following ways:-

- 1. Use of mobile Governance.
- 2. Providing customize alerts.
- 3. Disseminate of information related to Government matters.
- 4. Increase in productivity.

- 5. Increase in satisfaction level of citizens & tourists.
- 6. Scalability.
- 7. Use of VOIP facility.

Such connectivity would facilitate speedier and secure transaction, knowledge and information dissemination, hassle-free interaction amongst stakeholders/duty holders. The establishment of secured Wi-Fi Network through Public Private Partnership would enhance broadband availability and connectivity. The revenue model may be either through collection of user charges or through Advertisement rights or both. ASCL is open to explore other revenue generating options. The interested bidders are requested to visit the above mentioned proposed sites. A pre- EoI meeting has been scheduled at ASCL office, AMC City Centre, 5th Floor, Agartala at 03 P.M. on date as mentioned in Schedule of bidding process, for discussions on the project including the proposed implementation model, options for revenue generation for the selected developer, concession period etc.

4. Instruction to Bidders

4.1 Eligible Bidders

- a. The Bidder may be a single entity or a group of entities (the "Consortium"), coming together to implement the Project. However, no Bidder applying individually or as a member of a Consortium, as the case may be, can be member of another Bidder.
- b. The term Bidder used herein would apply to both a single entity and a Consortium. The total number of Consortium members is limited to 2 including the Lead Member.
- c. The Bidder should have experience of establishing 2 nos. city/campus/area/school/college Wi-Fi.
- d. Other Pre-qualification criteria's are mentioned in Section 4.3.

For the purpose of this EOI:

- (i) Project scope includes creation of Wi-Fi Hot Spots across city to provide internet service within approx. 100 meters radius of installation location. Wi-Fi service will enable users to access broadband internet using their Wi-Fi appliances (i.e. Laptops, Tablets, Mobile Phones, and computers using Wi-Fi access point).
- (ii) ASCL is interested in understanding, if any innovative ways there might be to provide Wi-Fi Services to citizens at either no cost to ASCL or if possible as a potential source of revenue, which could be shared between both the parties.

All bidders satisfying the Pre-Qualification criteria specified in this Document shall be qualified for next stage i.e. RFP. However before issuance of RFP all of them will called for Presentation as per the schedule mentioned in this RFP, for assessment of approach of each bidder (not for elimination purpose).

All qualified Bidders will be invited to participate in the next round by issuing the RFP. In case of Consortium, the lead bidder shall only be qualified bidder. The consortium partner may be from qualified bidders or any other parties.

Scope of Work for the Bidder

The Scope of Work for the vendor includes design, implementation and operation, for the provision of 24X7 Internet Access by means of best available global standard technology for high speed wireless internet access to stake holders/citizens using Wi-Fi enabled devices namely Laptops, Smart Phones, Tablets etc. The vendor shall provide the detail information on service level standards for EoI, with respect to the following:-

- Implementation, Integration and Commissioning.
- Maintenance and Technical Support for 5 years.
- Replacement and repair.
- Technical training.
- Documentation.

- Supply, configuration and installation of the State of the art Wi-Fi service including internet bandwidth.
- Provide the web based portal for user to login / authentication for Wi-Fi Access.
- Provisioning the access control and audit trail mechanism as per industry standard and security norms defined by various regulatory bodies.
- Provide the web based management console to monitor and manage the Wi-Fi access.
- Facility to define rule based access depending on usage, time duration, etc.
- Facility to restrict access based on URL, application, category, signature, etc.
- Provision of customizable reports for Wi-Fi Access Logs.
- Facility to enable / disable specific user / system from Wi-Fi Access.
- To set privilege based wireless access to different group of users according to the requirement of ASCL.
- Centralized authentication mechanism through individual user name-password based Radius Server/ Active Directory/ LDAP Integration, centralized MAC address filtering or certificate/ shared key based authentication for all respective users from central location.
